



**ORDER**

1. This is an execution application filed by NXTEP Maintain Infraz Pvt Ltd and another complainants-applicants against the respondent Jatin Samant for execution of order dated 29.09.2021 of this Authority.
2. Briefly, it may be noted that vide order dated 29.09.2021, the respondent was directed to pay a sum of Rs.76,464/- (i.e. Rs.64,800/- on account of arrears of maintenance charges at the rate of Re.1/- per sq. foot per month w.e.f. April 2017 till March 2020 alongwith an amount of Rs.11,664/- on account of GST at the rate of 18%) with interest at the rate of 9.30% per annum (that day's highest MCLR rate of 7.30% plus 2%) within a period of two months from the date of that order. Since, the order has not been complied with, the


complainants-applicants have filed the instant execution application for recovery of the amount due.

3. None appeared on behalf of the respondent, pursuant to notice of this execution application despite service of notice through his relative and also by affixation of the notice on the wall of his house. As such, respondent was proceeded against ex parte.
4. Arguments on behalf of the complainant-applicant were heard. The order dated 29.09.2021 passed in complaint GC No.1663 of 2020 has not been complied with so far. In the circumstances, it is ordered as follows:-

- i. The respondent is directed to pay Rs.76,464/- (i.e. Rs.64,800/- on account of arrears of maintenance charges at the rate of Re.1/- per sq. foot per month w.e.f. March 2016 till March 2020 alongwith an amount of Rs.11,664/- on account of GST at the rate of 18%) with interest at the rate of 9.30% per annum, which comes to Rs.1,21,430/- as per calculation sheet Annexure-A1.

5. In the result, the execution application is accordingly allowed. Recovery certificate be issued to the District Collector SAS Nagar (Mohali).
