After arguing at length learned counsel for the appellants states that since the agreement which is sought to be executed by the respondent lays down conditions which were never conceived of at the time when booking was done by the appellant, such an agreement will not withstand the scrutiny of law.

We are of the opinion that at this stage merely a draft agreement has been proposed and the actual agreement has still to see the light of the day. We would thus refrain from interference at this stage. Besides we are also of the opinion that if any agreement is being executed contrary to the rights of the appellants this would give them a fresh cause of action to dispute the same and establish so, in an appropriate proceedings.

POELLATE TRIBUING PRINTED TO THE ESTANDING ARMY TO THE CHANDIGARY

Learned counsel for the appellants states that he would take recourse to his legal remedies in law after withdrawing this appeal. The appeal is therefore disposed of as withdrawn in view of the above.
