- 1. Even though substantive issues are involved in all the appeals yet a preliminary question was raised by the appellants "whether an order pronounced after more than 3 years of its hearing would be sustainable or not".
- 2. Arguments on the aforesaid issue have been raised by the learned counsels for the appellants in their appeals and in support thereof, reliance has been placed in Info-Edge (India) Ltd Vs. Mumbai Grahak Panchayat and Ors. and related appeals passed by Maharashtra Real Estate Appellate Tribunal, Mumbai.

3.

There is indeed an inordinate delay between the hearing of the matter and pronouncement of the judgment. Numerous pronouncements on the said issue have been made by various Courts as also the Hon'ble Supreme Court, in order to obviate the chances of miscarriage of justice, lest the issues raised by a litigant are lost in the maze of time, elapsing between the last date of hearing and the pronouncement of judgment, such a practice has not only been discouraged but has been adversely commented upon to hold the resultant orders invalid.

- 4. Having regard to the aforesaid we consider the delay of approximately 3 ½ years intervening between last hearing and in pronouncing the orders as fatal to the cause of justice, particularly when the Hon'ble Member of Real Estate Regulatory Authority, Punjab (hereinafter known as the Authority) who passed the orders was to demit Office shortly upon completion of his tenure.
- 5. We thus deem it appropriate to set aside the impugned order and remit the matters back to the Authority for consideration afresh.
